Membership Eligibility

AAIP membership is open to any business entity (corporation, partnership, joint venture, trust or other enterprise) headquartered in the United States that supports the purposes, goals and objectives of AAIP.

Public Disclosure of Membership

AAIP members have the choice of whether to publicly disclose their membership on AAIP's website and in other AAIP materials. Members that decide to publicly acknowledge their membership are requested to submit a high resolution company logo. Unless required to do so by law, AAIP will not publicly disclose AAIP members.

Terms and Conditions

- » A Full Member (Class A Voting Member) is any business entity (corporation, partnership, joint venture, trust, or other enterprise) headquartered in the United States that supports the purposes, goals and objectives of AAIP.
- » Once submitted, this application will be considered by the AAIP Board of Directors.
- » If approved, the membership term will be for one year beginning on the approval date.
- » Dues must be paid within 90 days of receipt of invoice.
- » Members are entitled to the full benefits of their respective membership level.
- » Any Member can be expelled by a two-thirds vote of the Board of Directors.
- » Any Member, upon written request addressed to the Board, may resign from AAIP.
- » Paid membership dues shall not be refunded to any member which resigns or which membership is terminated.
- » The Designated Member is the primary contact and official representative of the member company to AAIP – there can only be one Designated Member from each member company.
- » Memberships renew on the original membership approval date, and at the current class and division level, unless otherwise instructed by the member.
